In a continuation of the saga of the pre-World War II painting hanging in a museum in Austria, this story focuses on a different couple but includes a lot of “air time” for Gerald and Dieter, the original couple. The famous painting is one that was stolen from Dieter Krumpf’s family when the Nazis occupied Austria, and this installment features Brian Watson, the attorney who took over the case from Dieter’s now life partner, Gerald, when the two became a committed couple.

Previously married, Brian has a little girl named Zoe who’s a sweetheart. A bit precocious, she’s not overly so, and when Brian meets a man who lights up his heart and libido but who happens to be deaf, Zoe joins Brian in learning sign language so Nicolai, an art restoration expert and the wonderful man who captured her father’s eye, won’t feel left out of conversations when he comes to visit or they go places together.

Those who love Andrew Grey will recognize his work as he builds an interesting story, no doubt based in part on a news story that caught his attention, but as always, it’s filled with love, romance, friendship and family. The good guys will prevail—eventually, and in the meantime, Brian and Nicolai will fall in love. The epilogue conclusion is in part a conclusion for both stories as the courts make a final ruling on just who owns the Krumpf family collection, and our guys make good on their promise for a bright future.

I enjoyed this audiobook narrated by John Solo whose vocalizations were definitely distinctive, and he even managed the nasty ex-wife and the little girl without sounding campy. The pace was good, the story interesting, and as I said, the narration was quite pleasant to listen to. Fans of Andrew Grey’s work and those who enjoy an MM romance with an older man, or a bisexual man in his first male romance, or even those who like stories of men with children should all find this very satisfying.

Attorney finds physical and emotional chemistry with fine art restoration expert who is deaf. I didn’t read the precursor to this story but that was not problematic as this was perfect as a standalone. Brian is an attorney and in fact, a managing partner of his firm, raising his precocious young daughter (9) following divorce. He is for the first time, forced to take a look and explore his own identity, admitting that he is gay. Introduced by friends to an expert in art restoration, Brian is attracted and interested in Nikolai. An

added flavor to the story is Nikolai's deafness and his own work to be comfortable as a professional independent man.

The setting or framework of the story is a legal case involving provenance and ownership of a friend, Dieter's family art recovered following WWII.

This author explores intimacy in the relationship as a secondary factor to the relationship itself. Each man is somewhat recently single, learning about themselves and learning about each other. They are also developing and exploring how they are as a couple and as a family with Brian's daughter. I strongly appreciated that deafness was integrated into the story and how communication changes. This man, Nikoli was a strong, intelligent, talented professional with a need to use alternate methods of communication. Perfect handling of this sensitive topic.

The journey includes stressors involving Nikolai's ex-boyfriend, Brian's ex-wife who wants money, money, money and uses their daughter as bait. I didn't feel that the storyline regarding Justin, Nikolai's ex-boyfriend was complete. One day he was stalking Nikolai and then he stopped. I think that this could have been resolved a little better but in the scope of the story, this was a small hanging thread.

While the MCs in 'Artistic Appeal' are a different pairing a lot of the events from 'Legal Artistry' the first book in this series carry forward to this story resulting in the fact that while I may not have enjoyed the first book as much as this one, I am glad that I took the time to listen to 'Artistic Appeal' because it definitely was to my benefit when I got to this story.

Brian Watson is good friend of Dieter and Gerald the MCs from 'Artistic Appeal' as well as Gerald's colleague and the lawyer who takes over Dieter's case that started in 'Artistic Appeal' and resolves with this story.

When Gerald and Dieter invite Brian to a dinner party with the hopes of playing matchmaker with one of Dieter's friends things don't work out quite the way they're anticipating. It's Nicolai who captures Brian's attention. Nicolai is an art restorer who has been taking care of the artworks that have recently been returned to Dieter and he's fast becoming a dear friend to Dieter as well.

I really liked the character of Nicolai. He's deaf but he's portrayed as an independent, capable and very functional person. Like anyone who has a sensory impairment he's learned to adjust and compensate for his hearing loss.

Brian's recently divorced and has custody of his daughter, Zoe. Being single and gay is new for him and he's doing his best to keep his life balanced between work, parenting and just being a newly out gay man.

Both Brian and Nicolai had their share of added drama. Brian with his ex-wife, who to say the least is a real piece of work and his mother who, thankfully got her act together. For Nicolai it was his ex-boyfriend/turned stalker who randomly decides he wants Nicolai back after a year of separation.

Once again John Solo was the narrator for this story and overall I enjoyed his narration. He has a pleasant voice and adds variety and expression to the voices of the different characters ensuring that everyone doesn't sound the same...a definite plus in this listener's opinion. Admittedly my niggle was Zoe's voice and maybe I'm just too damned fussy, I'll own that. When it comes to children's voices I admit it, I'm a tough sell.

Having recently read a few of Grey's works, I've realized that he's kinda the consistent go-to for simple everyday romance with a decent amount of heat.

This sequel pretty much starts where Legal Artistry left off. Dieter and Gerald have won the first battle in obtaining Dieter's family's works of art that were lost amidst the chaos of WWII, and now Gerald's law partner, Brian, is taking over to see the rest of the legal battle through. When Brian was introduced in the first book, he was recently divorced from his wife, whom he married because she became pregnant. Though he worked hard on his marriage and raising their daughter, Brian always knew he was gay. Now free, he's finally able to explore that side of him, having never had the chance to do so.

As Brian's friendship deepens with Dieter and Gerald, it gives him the opportunity to meet the man who's helping Dieter restore the paintings he's already recovered. Nikolai immediately intrigues Brian, and Brian can't resist the mysterious man. Luckily, lust and attraction goes both ways.

So, basically this is a tale of how Brian finally puts himself first and explores his sexuality, dating for the first time ever. These two take it slow and for the most part, they have a nice natural progression. What made this story for me was Nikolai. He was a sweet character, strong and independent, and it was interesting to see how he adapted to his environment and various social situations. This showcased the everyday struggles he goes through, and it was done tastefully and with sensitivity. Nikolai's been burned pretty badly by a past relationship and though Brian is attentive and caring, he's reluctant to let go and trust others. Brian on the other hand, is not timid in letting Nikolai know just how much he wants him in his and his daughter's life.

At times, this did veer off into some instances of great melodrama, mostly involving Nikolai's disturbing stalker of an ex and Brian's over the top, horrible crazy ex-wife. Also, beware of some lovey dovey cheesiness and a 9 year old who's too smart for her own good.

In all, I'm very satisfied in finding out what happened with Dieter and his quest for his family's legacy, and I'm glad that both Brian and Nikolai find their happy ending with each other. Like I've said before, this was easy simple romance reading.
